

## **A Review of Randomized Clinical Trials Involving EMDR**

Research supports the efficacy of EMDR for the treatment of anxiety, PTSD, and the psychological impact of natural disasters and other distressing experiences. Post-treatment follow-up indicates that treatment gains tend to be maintained over time.
